PART 8 – RUMBLE

ARTICLE 38. Rumble (Belt Catching)

38.1 Description - Rumble is and sees itself as a precursor to the traditional martial arts, in which children will playfully what skills they need for fighting. Quickness, reaction, fairness, agility and fine motor skills are trained specifically.

38.2 Ages (the subdivision is based on body size, see description)

- **38.3 Uniform** All uniforms should show the country to be represented or the style. The sending country shall decide on the style of uniform. The name of the country shall be attached by printing or embroidery on the back. It is important to wear a Belt.
- **38.4.1 Performance** Both children are each equipped with 3 bands. These strips are attached to their Belt, each band = 1 on the right, 1 band on the left thigh and 1 band is in the middle. The one fighter who has pulled out after the first time, more bands as his opponent, wins the fight. The important thing is that it stretches immediately the hand with the Belt from the other competitor upwards. If he do this not immediately he gets no points.
- **38.4.1 Time -** The presentation must not be longer than 60 seconds to compete. If it is a draw 30 seconds extension.
- **38.5 Presentation area -** the area has no less than 6 x 6 m and to be located on Tatamis with a thickness of 25mm (like in Kickboxing).
- **38.6 Number of referees -** 2 referees. This award points from 1 point for the correct Pull the belt. The Referee shall award the point independently and relates the side judge in not clear ratings. Otherwise, the side judge for review of the athlete as well as to accept the drawn belt is committed.
- **38.7 Rating** points are awarded as follows: For the correct pull out a tape assigns the referees 1 point. The ratings are awarded as in kickboxing (Point Fight) show of hands.
- **38.7.1 Rules** The two competitors greet each other and the judges. The referee gives the command "FIGHT". Then they can pull out the tapes of the enemy only with their hands. Do not hold the hand of the enemy, or pinch your own bands with the arm there. No punching techniques may be used (impact block)

The bands must be free for both tangible. It is also not allowed with anything other than the soles touching the mat, somersaults, knees, or roles is forbidden and is punished by a warning.

ATTENTION the tapes may only be loosely inserted in the belt and not be tied with this.

38.7.2 Warnings (time is stopped)

For holding or not a rule-compliant ground contact, the referee speaks each made a warning. The warning applies rules similar to kickboxing.

3rd Warning = 1 point MINUS (a belt less)

38.8 Protective Equipment

For protection they need a head protection (head Guard). Also, a mouthguard is recommended, but not required

PART 9 - NO CONTACT

ARTICLE 39. No-Contact

39.1 Description - No-contact sees it self as a precursor to the traditional martial arts, in which children will playfully learn what skills they need for fighting. Quickness, reaction, fairness, agility and fine motor skills and technique by hitting and kicking are trained specifically.

39.2 Ages (the subdivision is based on body size, see description)

39.3 Uniform - All uniforms should show the country to be represented or style. The sending country shall decide on the style of uniform. The name of the country shall be attached by printing or embroidery on the back. It is not important to wear a Belt.

39.4 Performance - Both children fight against each other without being able to touch each other. Targeted punches and kicks that would meet and have been executed correctly, are valued by the judges. It is forbidden to touch or to be taken. NOTE: since this is to children of various graduations and styles is not only the quality and design but also the number of techniques crucial.

39.4.1 Timeout - The presentation must not be longer than 60 seconds to complete. A draw - 30 seconds extension.

39.5 Presentation area - the area has to be not less than 6 x 6 m and is located on Mats/Tatamis with a thickness of about 25mm (as in kickboxing).

39.6 Number of referees - 2 referees. This award points from 1 point for the correct carrying out a technique. The Referee shall award the point independently and relates the side judge in unclear ratings. Otherwise, the side judge for review of the athlete is obliged.

39.7 Rating - points are awarded as follows:

For the correct running of kickboxing techniques with Kicks and Punches – If the techniques work as in a normal fight - the referees give one point each. The winner will be awarded as in light contact after the end of time by means of hands (in the corner of the winner) of the two judges.

39.7.1 Rules

The two contestants greet each other with Shake Hands, then the referees and start after the command "FIGHT" with the competition. It must touch the ground any other parts of the body other than the soles of the feet.

They sparring to each other without body-contact. Showing their kickboxing techniques as well.

39.7.2 Warnings (time is stopped)

For touching or not a rule-compliant ground contact, the referee speaks each made a warning. The warning applies rules similar to Kickboxing.

- 1. Warning
- 2. Warning

3rd Warning = 1 point MINUS (a belt less)

39.8 Protective Equipment

For protection they need a head protection (head Guard). Also, a mouthguard is recommended, but not required
