GENERAL EXAM DIRECTIVES OF THE WMAC

WMAC 2015

Introduction:

The exam directives of the WMAC were settled cheers a global student & Dan Graduation. Herewith we guarantee no classifications can give without fulfilling for it directives specific for style. The exam committee WMAC passes of specialists everybody at least 4. Dan must hold. Here it is about custody of the criteria for the reaching of a classification. Therefore, our member's organisations are integrated very strongly into the check and are not incapacitated.

A.) Students classifications and their check (to brown belt)

All members WMAC may carry out Students classifications in her style themselves. The necessary exam committee is put therefore by the member itself and has to go at least from a person with 1. DAN in the respective sport are equipped. This is called 1 if the association trainer. DAN may can prove he all Students check carry out. NO registration is necessary, on this occasion, also to the WMAC.

B.) 1.-3. Classification DAN and their check (Master Certification)

All master classifications they are recognised by the WMAC, must follow special directives. The expiry is as with the Students classifications. There must be an exam committee with 3 Dan-carrier from what at least one 4. DAN can prove. The WMAC sent or commissioned, an assessor (this is also followed part of this 3rd committee) him the check. This assessor May covalue, however, does not preside during the check and it the chairperson of the commission decides on the result.

Should WRONG misdemeanours or arrangements take place, the assessor can apply for the annulment of the check with the WMAC.

C.) Check from 4. DAN and higher (Grand Master Certification)

All master degrees from the 4th degree are valid as special ones HONOURS and LOADS of the respective candidate. There are styles with these there is from 3. DAN only honorary classifications and these are lent therefore we Distinguish 2 kinds of the check:

LENT CLASSIFICATION DAN – an application for afterwards higher certification can be made, on this occasion, at the end of the waiting periods to the WMAC.

Conditions:

- Finishes waiting periods (1. – 3. DAN in each case 2 years, from 3. to 6. DAN in each case 3 years, from 6.DAN to 9. DAN in each case 4 years)
- at least 3. DAN
- active trainer / practise leader of a fight sport institution (member WMAC)
- active competitor or Instructor of a competition group
- Minimum age 25 years
- Judge's education
- The first aid course max. 4 years old

EXAM DEFAULT

Here is valid again the principle of the PROTECTION of the respective STYLE DIRECTIONS. Be with this Dan Certification MUST guaranteed the respective candidate really the level of a Grand Master with himself brings. For it default is to be followed of course the physical, spiritual and as well as technical aspects contain.

According to him the exam committee of the following masses consists.

It are to be put at least 3 examiners their lowest classification of 4. DAN is and the WMAC it puts / or names the chairperson him at least 6. DAN corresponds and brings about an acted education in the examining style.

For the licensing to 9. DAN needs it an approval of the board of directors WMAC.

10. DAN may be lent only posthumous.

D.) Lending of HONOUR TO DEGREES DAN

For special salaries around the respective sport (style kind) so-called HONOURARY DEGREES can be applied with the board of directors / WMAC. The HIGHEST HONOURARY DEGREE to be lent is 3. DAN. This title HONOURARY DEGREE must be noted clearly evidently on the document. Nevertheless, to the HONOURARY DEGREE of receivers it is prohibits to present itself to me to the black belt it there is ONLY one recognition degree.

Conditions:

- Least 10 years activity for the institute to be lent
- Minimum age 35 years
- Special salaries around the sport / sportsman
